This contract is nontransferable or assignable. **MUST be returned to Triple 7 Equine by May 1<sup>st</sup> 2027.** Mare must be registered in contract holder's name. **DO NOT RETURN CONTRACTS VIA EMAIL.** Each contract holder must complete a separate form for each mare being bred. If you are splitting an early booking deal with one or more people, please note the split at the bottom of the form and include the names of everyone involved. This will help us keep track of how the special was divided and ensure all contracts are properly connected in our records.

### Breeder and Mare Owner agree to the following conditions:

The mare owner is booking a 2027 early booking fee; please check one of the following boxes:

The balance of the collection/shipping must be paid in full before semen is shipped, no exceptions. This contract must be returned to Triple 7 Equine, LLC by May 1<sup>st</sup> to be valid for the upcoming season. **No refunds will be given for any reason.** If breeding the mare on site at Triple 7 Equine, mare owner is responsible for all breeding fees, which are to be paid directly to Triple 7. All mares **MUST** be registered in contract holder's name.

This contract contains a **Life Foal Guarantee**. A live foal is described as a newborn foal which stands and nurses without assistance. Should the mare fail to have a live foal, as defined above, the mare owner has the right to return the mare for rebreeding in the succeeding year only. Mare owner must notify the breeder within 48 hours and send a veterinarian's statement.

The breeder **MUST** be notified 24 hours in advance of collection day to insure your shipment. Shipment days are Monday, Wednesday, and Friday from February 1<sup>st</sup> – July 31<sup>st</sup>, except for Memorial Day, there will NOT be shipments on this day, or any FedEx Holiday. No mares will be bred with fresh semen after July 31<sup>st</sup> of any year. Confirmation or cancellation may be made by **8am CST** the day of shipping. Cancellations not called in by **8AM CST** will be charged for that shipment. Shipments are filled on a 1st come 1st serve basis. Please remember that a cooled semen contract does not guarantee semen will be available. In the unlikely event of insufficient semen on a particular breeding day, the breeder reserves the right to determine which mares will be bred based on reproductive status. Fresh semen shipments are \$500. Frozen semen shipments are \$600. **ALL Shipping containers need to be returned to Triple 7, if not returned mare owner will be billed an additional \$75 to replace the box. Please note that any semen orders not cancelled by 8AM CST the mare owner is liable for ALL shipping fees.**

It is further agreed that should the stallion die, be sold, or become unfit for service at any time, then this contract shall become null and void. **No fees will be refunded for any reason.** When booking to RN Highbrow Lena the mare owner assumes all risk.

No mare will be bred, and semen will not be shipped without a completed Stallion Breeding Contract that is signed by mare owner; at this time, the contract will be a binding contract of both parties, subject to the above terms and conditions, and ALL fees paid in full. **Contract MUST be mailed to the address listed at the top of the contract by May 1<sup>st</sup>.** **DO NOT RETURN CONTRACTS VIA EMAIL.** Make checks payable to Triple 7 Equine. We ship via UPS; FedEx shipments are an additional \$100.

If you are splitting a contract with one or more individuals, please list each person's name below and clearly indicate how the contract will be divided. Contracts may be split in any way you choose and among as many individuals as you would like. We simply ask that you provide clear details showing which individuals are connected to each contract so we can keep our records accurate and organized.

## IMPORTANT INFORMATION

When booking to RN Highbrow Lena mare owners have THREE options:

**First and foremost, we stand multiple stallions, make sure to let us know which stallion your mare is booked to when communicating with Triple 7 Equine.**

- ✘ **#1: Haul the mare to Triple 7 Equine in Sedalia, MO.** This is our own personal breeding facility. We will be able to breed the mare on site with cooled fresh semen. If the mare owner chooses this option, they will not need to pay shipping fees. Mare owner will still be responsible for the cost of collection and processing of semen. The associated cost would be paid by mare owner directly to Triple 7 Equine. Please contact Triple 7 Equine directly to make an appointment for your mare (660) 898-8510. [Triple 7 Equine – 22299 Sacajawea Road, Sedalia, MO 65301]

Please keep in mind if you plan to haul your mare to Triple 7 Equine we typically book a month out. Call to get your mare on the books early! (660)898-8510. **You must make an appointment, do NOT just show up.**



- ✘ **#2: Mare owner can personally pick the semen up from Triple 7 Equine (Sedalia, MO) and personally transport to vet of choice,** mare owner must still pay cost of collection and processing of the semen. It will cost a total of \$300 for collection and processing of the semen. It must be paid when semen is picked up, or before.
- ✘ **#3: Have the semen shipped to the vet of choice by mare owner.** Shipping fresh semen is \$500. Shipping frozen semen is \$600. The shipment and stud fee MUST be paid in full before we will ship any semen. No exceptions. **We ship on Monday, Wednesday, and Fridays except for Memorial Day AND any FedEx Holidays.** Frozen semen can be shipped at anytime year-round. Breeding season is now February 1<sup>st</sup> – July 31<sup>st</sup>.

**To order shipped semen please text or call Triple 7 Equine (660)898-8510.** We do require a 24-hour notice. We try to be flexible and might be able to get a shipment last min. but it is not guaranteed without a 24-hour notice. **Please text. We do not accept any semen orders via voicemail.** Please send us your vets name, clinic name, shipping address, vets' email, vets' phone number, mares REGISTERED name. We need this information ready for shipments. We will not ship without the complete information at the time semen is ordered. Please also confirm which stallion semen is requested of.

**Important Notes:** We do NOT offer counter to counter shipments. If your mare is not in foal by July 31<sup>st</sup> you will have to use frozen semen. No fresh semen shipments after July 31<sup>st</sup> yearly. **\*\* IF paying by check, make all checks payable to Triple 7 Equine \*\* Checks must be received BEFORE semen is shipped.** We ship via UPS; FedEx shipments are an additional \$100.

**IF your vet adds you to our list for a semen shipment and does not cancel by 8AM CST, you must pay those shipping fees. NO EXCEPTIONS!!!! Your vet needs to have clear communication with us when ordering semen.**

Once the mare is confirmed in foal, please report breeding dates and confirm with Michelle Hamilton that all mare information is correct for the breeding report. It is the mare owner's responsibility to confirm this information to make sure it is correct. **If not done this could result in the foal not being able to be registered.** Please double check to make sure all information on the contact is 100% accurate.
